Please advise at your earliest opportunity when this column will appear.

Leila Paul London, ON, LFP's June 3rd column "So young may understand, Huron should not give in" serves an excellent example of what journalism can do. It can enhance understanding and knowledge by revealing what underlies controversial issues.

The headline is somewhat misleading for not just young minds need to understand emerging global issues like the growing influence of Islam. As a 65-year-old I'm once again a student and hope to take some of these courses at Huron. I'm already somewhat knowledgeable on the subject of Islam and how it has interacted with Christianity and Judaism over the centuries. But I'm eager to undertake formal study.

Huron is to be commended for seeking to create understanding of the complex relationships of these three faiths. Politics and rivalries have trod on the sensitivities of their adherents. But if these influences are removed, better understanding can emerge.

The June 3rd column creates the impression the only organizations willing to contribute to an Islamic Studies Chair are Islamic and some of their activities or members are suspected of sympathy or ties to terrorism.

Education must be free from suspicion or political objectives. As a former journalist who's reported in Israel-Palestine for an ABC-TV affiliate in New Orleans, I know something about the preceding organizations that gave rise to those funding the Islamic Chair.

So I'm eager to know what methodical, investigative steps Huron has on record regarding its assurance that these organizations have charters compatible with Huron's educational obligations within the Canadian context.

Claims of due diligence by Huron would be comforting if that diligence is described. But nowhere have I seen any description of what diligent investigations have been undertaken.

The Muslim Association of Canada (MAC) makes distressing claims that offend me as a Christian and a woman. The International Institute of Islamic Thought also causes me some trepidation. I will be reassured once I see the details of what specific investigations have been undertaken in Huron's due diligence.

Universities teach that contentions must be backed up by research with citations to prove their credibility. If I wrote an academic paper making assertions without evidence and citations, the lecturer would reject the paper or grade it very poorly.

The LFP now can describe to taxpayers and help Huron College report its diligence so taxpayers, whose funds support both Huron College and the University of Western Ontario, can take comfort in knowing the donors are not tainted by terrorist sympathies.

Taxpayers and students need to be assured the honourable objectives and reputation of Huron will not be innocently affected by tainted funds in its eagerness to accommodate a worthy program of study.

Those who proposed the Islamic Chair must be known to both be and be seen to be free of any association with terrorists. Most importantly, they must be known to never have expressed sympathy with terrorists.

Funding should be sought from other sources besides Muslim organizations which may be suspicious or whose objectives isolate their Muslim youth. The MAC should open wide its own program to non-Muslim youth. In the true spirit of Canadian egalitarianism, the MAC should encourage interaction between boys and girls of all three faiths in joint activities rather than retain gender segregation.

When the MAC shows that it's open and welcoming to non-Muslims it will go a long way to reassuring Canadians that its objectives in funding the Islamic Studies Chair are honourable and encourage harmonious interactions and understanding among the three

faiths.

Then, young minds - and older minds - may find there's more inclusiveness in Islam than appears to be the case now.
